## **Insurance cover**

### TRANSPORT LIABILITY

TVM Insurances confirms that the above-mentioned client is insured with our company for transport liability (CMR) according to policy conditions CMR 01012022 B.

### **Transport liability**

Insured objects	All vehicles insured in the policy on the date of this certificate.

#### Maximum compensation:

- Insured maximum amount per vehicle: €335,000
- Per event or series of events with the same cause: €945,000
- -Storage and Transshipment (prior & intermediate): €150,000

Nature of goods: coils. In the warehouse at Oevel, Nijverheidsstraat 28.

The premises of the policyholder are considered by the insurer as a non-public road. Parking Nijverheidsstraat 28 in Westerlo.

Trailers may be uncoupled when loaded. Coverage is provided for this. The insured is exempted from the requirement of a kingpin lock in case of theft.

- Uncoupled trailers, except for parking in Nijverheidsstraat 28: €125,000

### Exemption:

- -Contamination damage (third party cleaning): €500
- -Bulk goods by tankers and containers (incl. covered and tilt transports): 10% of the damage with a minimum of €250 and a maximum of €750

In case of theft of goods, the insurer will look first at the value of the stolen goods.

#### THEFT - EXEMPTION.

#### -Coupled vehicle:

Theft below 80% of the total value of the goods: application of the ordinary exemption (10% of the damage with a minimum of  $\in$ 250 and a maximum of  $\in$ 750).

Theft above 80% of the total value of the goods: application of the ordinary exemption (10% of the damage with a minimum of  $\le$ 250 and a maximum of  $\le$ 750).

### -Disconnected vehicle:

Theft below 80% of the total value of the goods: application of the ordinary exemption (10% of the damage with a minimum of  $\le$ 250 and a maximum of  $\le$ 750).

Theft above 80% of the total value of the goods: exemption of 10% of the damage with a minimum of €6,250 and a maximum of €12,500, applicable for all categories of goods. Rovetra may unhitch their loaded trailers in their parking lot in the rue de l'Industrie. In case of theft, the ordinary exemption applies: 10% of the damage with a minimum of €250 and a maximum of €750.

This cover is valid from 01/01/2025 until 01/02/2026, provided that the premium is paid.
